POLICY MANUAL - CHURCH MEMBER

1. Members are admitted to the church by grace, through faith in Jesus Christ as the Son of the Living God; repentance from sin; confession of their faith in Jesus Christ before witnesses; immersion for the remission of sins; and by signifying their desire to grow in Christian living and become part of the Congregation (Article III, bylaws).
2. Every member has equal rights and obligations.
3. Members may be expelled from the Congregation when their actions or speech do not reflect Christ like qualities or continuous slander or libel against fellow Christians to bring them to disrepute through false or malicious statements.
4. Expulsions maybe based on deviations like sexual immorality, spousal or child abuse, idolatry, witchcraft, drunkenness, drug addiction, unscrupulous business dealings or rejection of the foundational doctrinal beliefs of the churches of Christ. Further grounds for expulsion are spelled out in Galatians 5:19-21; Colossians 3:5-9; Revelation 21:8; and other specific New Testament teachings.
5. Active members must attend regular church worship services unless prevented by sickness, accident, or conditions of employment and shall have the right to vote on all matters that are put before the congregation.(Article II, Section 4, bylaws).
